

## Terms and Conditions for Income's Fallin' Apart Cover Contest

- Participation of the Income Insurance Limited ("Income") Fallin' Apart Cover Contest
  ("Contest") constitutes acceptance of these terms and conditions ("Terms and
  Conditions").
- The contest will be held from 1 September 2023 till 2359 hours, 22 October 2023.
- To enter into the contest, Contestants ("Contestants", "Contestant") must:
  - 1. Record their "Fallin' Apart" vocal performance on camera.
  - 2. Share on Facebook/Instagram/TikTok with the hashtags #IncomePresentsFallinApart #FallinApart and why the song resonates with them. Their social profile must be set to public.
