The sub-fund seeks to achieve medium to long-term capital appreciation.

Investment Scope

The sub-fund intends to achieve the objective by investing all or substantially all of its assets into Nikko AM Shenton Horizon Investment Funds - Singapore Dividend Equity Fund - SGD Class ("underlying fund").

The underlying fund may use financial derivative instruments ("FDIs") for the purpose of hedging the underlying fund's existing portfolio.

The sub-fund is denominated in Singapore Dollars.

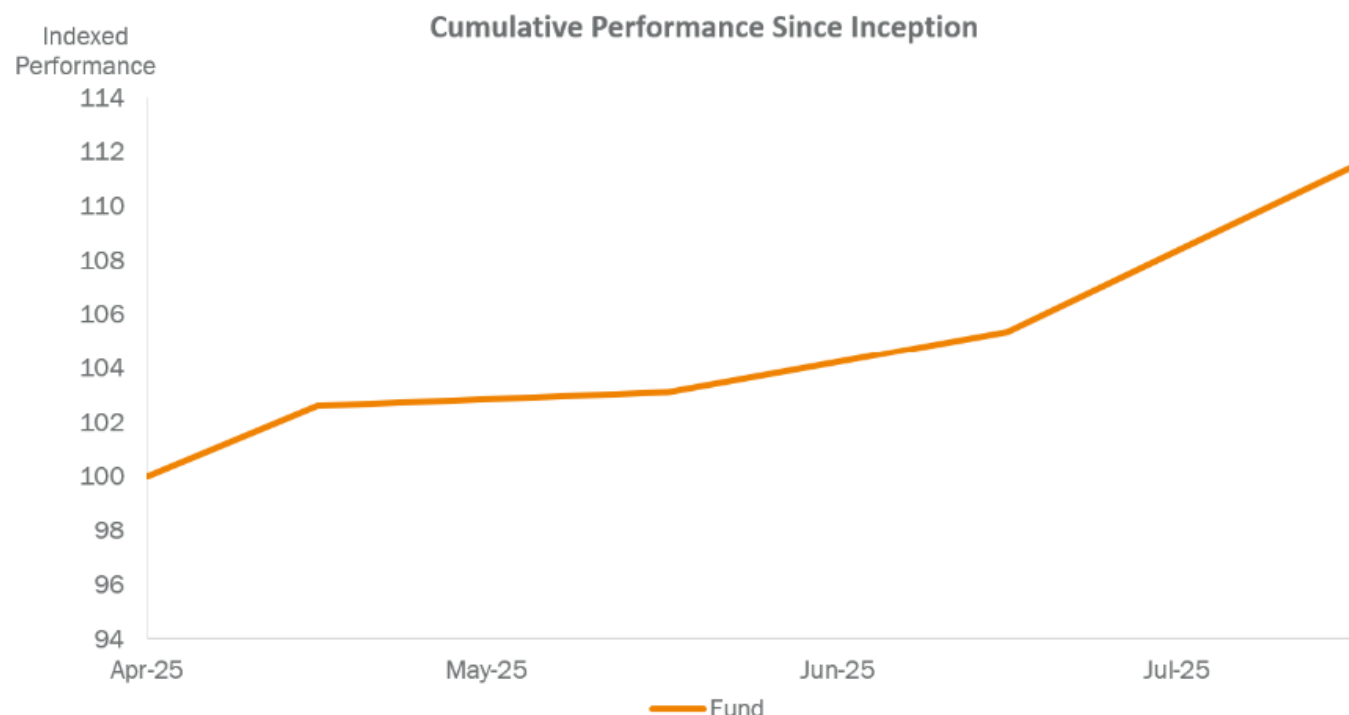
