Complimentary Monkeypox Benefit Extension



- 1. This Monkeypox Benefit Extension cover is for the following **eligible PA policies**. "**Eligible PA policies**" mean the following Personal Accident plans and policies with infectious diseases cover:
 - a) PA Assurance with infectious diseases cover
 - b) 150
 - c) PA Secure
 - d) SpecialCare (Autism)
 - e) SpecialCare (Down Syndrome)
 - f) Personal Accident Infectious Diseases (PAID)
- 2. This Monkeypox Benefit Extension forms part of the respective **eligible PA policies** and shall be read, interpreted, and construed as one document.
- 3. The Monkeypox Benefit Extension is provided complimentary at no additional cost and is valid until 31 Dec 2022 while **you** hold a valid **eligible PA policy**.
- 4. The Monkeypox Benefit Extension will be withdrawn from the date that **monkeypox** is declared an epidemic by the health authority in Singapore or the Government of the Republic of Singapore, or a pandemic by the World Health Organisation (WHO) and will be reinstated when **monkeypox** ceases to be declared as an epidemic or a pandemic.
- 5. We reserve the right to make changes to or withdraw these benefit extensions at any time without any prior notice.



Community hospital means any approved community hospital under the relevant national laws and regulations that provides an intermediate level of care for individuals who have simple illnesses which do not need specialist medical treatment and nursing care.

Eligible PA policies mean the following Personal Accident plans and policies with infectious diseases cover:

- a) PA Assurance with infectious diseases cover
- b) 150
- c) PA Secure
- d) SpecialCare (Autism)
- e) SpecialCare (Down Syndrome)
- f) Personal Accident Infectious Diseases (PAID)

Family member means **your** husband or wife, children, parents, brothers and sisters, parents-in-law, brothers-in-law, sisters-in-law, grandparents, grandparents-in-law, daughters-in-law, sons-in-law, or grandchildren.

General practitioner means any person registered and legally qualified by a medical degree in western medicine and authorised by the medical licensing authority of Singapore to provide general medical care. This should cover a variety of medical problems in patients of all ages. This often includes referring patients to an appropriate **specialist**. This person should not be **you**, **your family member**, partner, business partner, employer, employee, or agent.

Hospital means an establishment which is registered under the relevant national laws and regulations to care for and treat sick and injured people as bed-paying patients and which:

- a) has organised facilities for diagnosis, treatment and major surgery;
- b) provides nursing services by registered nurses 24 hours a day;
- c) is under the supervision of one or more medical practitioners; and
- d) is not mainly a clinic, a **community hospital**, a secure place to care for alcoholics or drug addicts, a nursing, rest or convalescent home or a home for the elderly or a similar establishment.

Medical practitioner means any person registered and legally qualified as a doctor by a medical degree in western medicine and authorised by the medical licensing authority of that country to provide medical or surgical services within the scope of their licence and training. The **medical practitioner** cannot be **you**, **your family member**, partner, business partner, employer, employee, or agent.

Monkeypox means a viral disease that is caused by infection with the monkeypox virus.

Specialist means a **medical practitioner** who has the necessary qualifications and expertise to practise as a recognised specialist of diagnostic techniques, treatment and prevention, in a particular field of medicine like psychiatry, neurology, paediatrics, endocrinology, obstetrics, gynaecology, orthopaedics, optometry and dermatology.
